	<p>Outcome: See attached presentation.</p> <p>Questions for Tom</p> <p>Question: From the graphs presented, it appears we will be able to continue rafting in the upper portion of the Truckee through the 1st week of August. Is this correct?</p> <p>The current model shows flows will likely be 220 cfs around August 4th and dropping to 200 cfs around August 7.</p> <p>Regarding the TROA annual report and California guidelines: Will there be a point when we can assess the CA Guidelines as related to fisheries?</p> <p>This is a complicated question to answer. We can analyze whether or not we are hitting the flow targets, but ultimately, we would need to conduct fish surveys at various flow rates to be able to fully determine the impacts on fisheries. USFWS or CDFW may have better data on this that could be correlated.</p>
